ORDER RESCINDING NOTICE AND ORDER OF LICENSE REVOCATION

THIS MATTER comes before the New Mexico Office of Superintendent of Insurance ("OSI") by the Superintendent upon his own motion following the submission of a statement of compliance. Having examined the OSI docket and being otherwise fully informed,

THE SUPERINTENDENT HEREBY FINDS:

 On August 4, 2022, a Notice and Order of License Revocation ("Notice and Order") was filed against Cory White ("Respondent") alleging a violation of Section 40-5A-6 of the Parental Responsibility Act.

1. Pursuant to NMSA 1978, § 59A-11-14(A)(13), OSI may revoke a license issued under Chapter 59A, Article 11 NMSA 1978 for the failure to comply with an administrative or court order imposing a child support obligation.

2. The *Notice and Order* stated that Respondent needed to either request a hearing on the matter or provide OSI's Producer Licensing Bureau ("PLB") a statement of compliance within ninety (90) days of the filing of the *Notice and Order*.

3. In response to the *Notice and Order*, on or about August 4, 2022, Respondent sent PLB a certification of compliance generated from the New Mexico Child Support Enforcement Division. *See* Exhibit A.

4. Submission of the certificate of compliance resolves the issue at hand.

IT IS THEREFORE ORDERED:

- A. The *Notice and Order* filed on August 4, 2022, is hereby rescinded.
- **B.** PLB shall update their records to reflect that Respondent is in good standing regarding this licensing requirement.
- C. No further action will be taken against Respondent at this time.
- **D.** This docket hereby is closed without further action of the Superintendent.
